5. The parties interested to- participate in the tender will have to deposit an earnest money of Rs. 10000;- (Ten thousand only) in the shape of bank draft or pay order in favour The Haryana State Co-Operative Supply & Marketing Federation Ltd payable at Ambala to be eligible for the tenders.
6. The parties can inspect the material on site on any working day and at the time of tenders it will be presumed that the stocks have been inspected by the parties and no correspondence will be entertained later on in this regard.
7. Successful tenderer will be required to deposit 25% amount of the total cost of the material as security in addition to earnest money within 72 hours after confirmation of offer, failing which the amount of earnest money deposited shall be forfeited. However, earnest money will be adjusted in the final bill after completion of work.
8. The earnest money of the unsuccessful tenderer will be refunded after finalization of the tender as per rules and practice.
9. The successful tenderer shall lift the material within 30 days after issue of sale letter. After that storage charges will be charged on account of late lifting of material on weekly basis.
10. Hafed will not be liable for payment of interest on earnest money/security deposited with this office.
11. The earnest money and security of the successful tenderer shall be adjusted towards the cost of the material in the last consignment.
12. VAT as applicable shall be charged extra on the material from the purchaser.
